504-014-244307 Mayfield Township – Coulter Road, Between M-24 & Valentine Road. Pump Pond down 4-5 Feet to the south with 6" pump. Install new 15"x21"x60' Poly coated arch pipe. Install 4x12 MDOT RIP Rapo. Restoration and pave crossing. This includes \$10,000 contingency for any unforeseen issues. Estimated Cost \$33,000.00. Twp.
