## Lapeer County Road Commission Lawn Maintenance

Work: Lawn Mowing and Trimming around Lapeer Service Center

Location: 820 Davis Lake Road, Lapeer, MI 48446

Frequency: May- June: Typically, two mowing's per week, unless otherwise notified  
July- October: Typically, one mowing per week, unless otherwise notified

Required: **INSURANCE REQUIREMENTS**  
The contractor shall save harmless and indemnify the Board of County Road commissioners of the County of Lapeer against all claims for damages to public or private property and for injuries to persons arising out of and during the progress and to the completion of the work.

The contractor shall, include with their bid, certificate that he carries **Worker's Compensation Insurance, with a 10- day notice of cancellation clause, liability amounts shall be \$500,000/\$500,000/\$500,000.**

The contractor, prior to execution of the contract, shall file with the department, copies of completed certificates of insurance as evidence that he carries adequate insurance satisfactory to the Road Commission, to afford protection against all claims for damages to property and injuries to persons arising out of and during the progress of the work. **The Road Commission shall be added to these policies as additionally insured, with a 10-day notice of cancellation clause.**

Minimum property damage and bodily injury liability covering each contract shall be:

Operations shall not commence until insurance is in force and will cease if it is canceled.

To Bid: Submit cost per mowing in a sealed envelope to Lapeer County Road Commission. Certificate of insurance will be required prior to final award to Contractor.
